

RESOLUTION NUMBER R- 305906

DATE OF FINAL PASSAGE JUN 21 2010

WHEREAS, the San Diego City Council adopted an ordinance, codified at San Diego Municipal Code section 26.16, establishing the Citizens Equal Opportunity Commission [Commission]; and

WHEREAS, section 26.16 provides that the Commission monitor and/or evaluate the City's Equal Opportunity Program; advise the Mayor, City Council, Civil Service Commission and other appropriate agencies; submit written quarterly reports to the City Council's Rules Committee and City Council; assist in recruiting competent, historically under-represented minorities, women and disabled to compete for City positions; and promote the City of San Diego as an Equal Opportunity Employer of individuals and firms desiring to contract with the City; and

WHEREAS, the ordinance provides that the Commission shall consist of eleven members appointed by the Mayor and confirmed by the City Council; and

WHEREAS, the ordinance provides that the Commission shall include one representative from each of the following historically underrepresented groups: Latino, African-American, Filipino, American Indian, Asian/Pacific Islander, Lesbian/Gay/Bisexual/Transgender and Disabled; and

WHEREAS, the ordinance provides that the remaining four members of the Commission shall be appointed from the City at large; and

WHEREAS, the ordinance provides that members shall serve two-year terms; each member shall serve until a successor is duly appointed and confirmed; and all terms must have expiration dates of January 1; and

WHEREAS, one seat is now to be appointed with a member; NOW, THEREFORE,
BE IT RESOLVED, by the Council of the City of San Diego, that the following
appointment by the Mayor of the City of San Diego to serve as a member of the Citizens Equal
Opportunity Commission, for a term ending as indicated, be and the same is hereby confirmed:

deliberation and consideration of appointment, it is determined that Mike Olivier is a resident of
San Diego County, but not the City of San Diego, and has unique qualifications to serve as a
member of the Commission, therefore, a conscious exception to Council Policy 000-13 is hereby
declared.
