A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE CHIEF FINANCIAL OFFICER TO APPROPRIATE AND EXPEND AN AMOUNT NOT TO EXCEED \$100,000 IN PROJECT FUNDS AND AUTHORIZE THE MAYOR OR HIS DESIGNEE TO ACCEPT REIMBURSEMENT FUNDS IN AN AMOUNT NOT TO EXCEED \$100,000 FOR A MOBILIZATION EXERCISE DRILL FOR URBAN SEARCH AND RESCUE CALIFORNIA TASK FORCE 8.

WHEREAS, the San Diego Fire-Rescue Department's Urban Search and Rescue [US&R] California Task Force 8, would like to participate in the Urban Search and Rescue 2010 Mobilization Exercise [Mobex] drill; and

WHEREAS, the purpose of the US&R system is to provide a nationwide network of heavy search and rescue teams that can be rapidly deployed to disaster incidents; and

WHEREAS, the individual teams are established at the local jurisdictional level and can be federalized and deployed by the State of California as needed for a statewide response; and

WHEREAS, the US&R teams provide an organized system of resources to locate, extricate, and provide immediate medical treatment to victims trapped in collapsed structures and to conduct other life-saving operations; and

WHEREAS, the US&R National Response System is responsible for the coordination, development, and maintenance of the federal effort in providing these resources to augment state and local resources in disaster situations; and

WHEREAS, the cost of the Mobex drill is reimbursable from the California Fire and Rescue Training Authority in an amount not to exceed \$100,000; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Chief Financial Officer is authorized to appropriate and expend an amount not to exceed \$100,000 in project funds for training authorized by the California Fire and Rescue Training Authority for the Mobex drill for US&R California Task Force 8 on June 23, 2010 and June 24, 2010.

2. That the Mayor or his designee is authorized to accept reimbursement funds in an amount not to exceed \$100,000 from the California Fire and Rescue Training Authority to pay for the execution and completion of the Mobex drill for US&R California Task Force 8.
