A RESOLUTION OF THE CITY COUNCIL AUTHORIZING A CONSULTING AGREEMENT WITH NINYO & MOORE FOR AS-NEEDED UNDERGROUND STORAGE TANK SITE ASSESSMENT AND MITIGATION SERVICES.

WHEREAS, in October 2009, the City issued a Request for Proposals to provide asneeded consulting for assessment and mitigation services related to the City's underground storage tank systems; and

WHEREAS, the firm of Ninyo & Moore was selected as the most qualified to provide the services; and

WHEREAS, on May 12, 2010, the Natural Resources & Culture Committee approved this item; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000,000 over the five-year term of the above Agreement for purposes of as-needed underground storage tank site assessment and mitigation consulting services, contingent on adoption of the Appropriations Ordinance for the applicable fiscal year and provided that the

City Comptroller first furnishes one or more certificates demonstrating that the funds necessary for expenditure are, or will be, on deposit in the City Treasury.

- 3. That the Chief Financial Officer is authorized to transfer excess budgeted funds, if any, to the appropriate reserves on advice of the administering department.
- 4. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,000 from Fleet Operations Fund No. 720000, solely and exclusively to provide funds for the minimum guaranteed as-needed task order(s) under the above Agreement.
