A RESOLUTION AUTHORIZING THE ACCEPTANCE AND EXPENDITURE OF FUNDS FROM A CALIFORNIA DEPARTMENT OF TRANSPORTATION [CALTRANS] GRANT FOR THE SAFE ROUTES TO SCHOOL PROGRAM.

WHEREAS, the State of California through the California Department of Transportation [Caltrans] administers the Safe Routes to School Program that funds projects that remove pedestrian barriers and improves safety in the vicinity of schools; and

WHEREAS, in Fiscal Year 2009 the City submitted three grant applications to the Safe Routes to School Program of which two were selected by Caltrans for funding in the amount of \$899,130; and

WHEREAS, these funds will be used to install safety improvements near Berry Elementary School, Emory Elementary School, Nestor Elementary School, and Mar Vista Middle School; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego as follows:

1. That the Chief Financial Officer or his representative is authorized to accept funds from the California Department of Transportation Safe Routes to School Program in the amount of \$899,130.
2. That the Chief Financial Officer is authorized to establish a special interest bearing fund for the grant.
3. That the addition of CIP L-00010 (Berry Elementary School, Emory Elementary School, Nestor Elementary School, Mar Vista Middle School), and CIP L-00011

(Berry Elementary School, Emory Elementary School, Mar Vista Middle School) to the Fiscal Year 2010 Capital Improvements Program Budget is authorized.

4. That the Fiscal Year 2010 Capital Improvements Program Budget is amended to add \$453,410 to CIP L-00010 (Berry Elementary School, Emory Elementary School, Nestor Elementary School, and Mar Vista Middle School) and \$445,720 (Berry Elementary School, Emory Elementary School, and Mar Vista Middle School).
5. That the Chief Financial Officer is authorized to appropriate and expend up to \$899,130 in the Fiscal Year 2010 Capital Improvements Program Budget with up to \$453,410 for CIP L-00010 (Berry Elementary School, Emory Elementary School, Nestor Elementary School, and Mar Vista Middle School) and up to \$445,720 for CIP L-00011 (Berry Elementary School, Emory Elementary School, and Mar Vista Middle School) contingent upon the Comptroller.
6. That the Chief Financial Officer, is authorized to transfer \$133,236 from CIP AIK-00002 (School Traffic Safety Improvements), \$67,045 to CIP L-00010 (Berry Elementary School, Nestor Elementary School, Emory Elementary School, and Mar Vista Middle School) and \$66,191 to CIP L-00011 (Berry Elementary School, Emory Elementary School, and Mar Vista Elementary School), within Fund 400169, TransNet Extension 70% Cap for the purpose of grant matching funds.
