A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE LEVY AND COLLECTION OF FISCAL YEAR 2011 ANNUAL ASSESSMENTS WITHIN THE DOWNTOWN PROPERTY AND BUSINESS IMPROVEMENT DISTRICT, AND AUTHORIZING THE APPROPRIATION AND EXPENDITURE OF FUNDS THEREFORE.

WHEREAS, pursuant to the Property and Business Improvement District Law of 1994 (California Streets and Highways Code section 36600 et seq.), a written report [Report] has been prepared for the Downtown Property and Business Improvement District [Downtown PBID] for Fiscal Year 201; and

WHEREAS, pursuant to Resolution number R-306026, the City Council approved the Report in connection with the Downtown PBID, which is on file in the Office of the City Clerk as Document No. RR-306026; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council hereby authorizes the levy and collection of assessments in the Downtown Property and Business Improvement District [Downtown PBID] to pay a prescribed portion of the costs of improvements and/or services in Fiscal Year 2011 as described in the Report.

BE IT FURTHER RESOLVED, that a full and detailed description of the boundaries of the Downtown PBID and any zone therein, the improvements and activities, the estimated cost of providing the improvements and activities, the method of levying the assessment, the amount of any surplus or deficit revenues to be carried over from last year, and the amount of any contributions from non-assessment sources are described in the Report submitted for the Downtown PBID and on file in the Office of the City Clerk as described herein.

BE IT FURTHER RESOLVED, that City staff may order a portion of the costs of maintenance for City-owned parcels, not to exceed \$277,176.39 to be paid by the City from appropriate funds.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, or his designee, is authorized to appropriate and expend Property and Business Improvement District funds for Fiscal Year 2011 in an amount as described in the Report for the Downtown PBID, contingent upon approval of the Fiscal Year 2011 Appropriation Ordinance and contingent upon Comptroller certifying that funds are available.

BE IT FURTHER RESOLVED, that the Chief Financial Officer, or his designee, is authorized to transfer an amount not to exceed \$130,000 from Fund No. 200108 to Fund No. 200086, and to appropriate and expend that amount for administrative costs incurred by the City in the course of providing administrative services to the Downtown Property and Business Improvement District.
