A RESOLUTION APPROVING THE PLANS AND SPECIFICATIONS, AUTHORIZING THE EXPENDITURE OF FUNDS AND RELATED ACTIONS FOR CONSTRUCTION OF SEWER GROUP 739.

WHEREAS, Sewer Group 739 [Project] is part of the City of San Diego's Main Replacement Program as mandated by the Environmental Protection Agency; and

WHEREAS, this Project is located in the Peninsula Community Plan area, and includes the construction and replacement of approximately 2188 lineal feet and the rehabilitation of 2930 lineal feet of existing vitrified clay sewer mains with new 8-inch polyvinyl chloride pipe and all other work and appurtenances; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego [Council] that the plans and specifications for the construction of the Project, as advertised by the Purchasing and Contracting Department, filed in the office of the City Clerk as Document No. RR-306041, are approved.


BE IT FURTHER RESOLVED, that after advertising for bids in accordance with law, the Mayor, or his designee, is authorized to execute a construction contract with the lowest responsible and reliable bidder, provided that the City Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer [CFO], as delegated to Financial Management is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$1,918,396.73 from Sewer Fund 700000, CIP A-JA.00001

(Legacy CIP 44-001.0), Annual Allocation – Sewer Main Replacements for this Project’s construction and related costs, contingent upon the City Comptroller first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
