A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO TO ESTABLISH THE SOUTH CLAIREMONT RECREATION CENTER AMERICAN WITH DISABILITIES [ADA] KITCHEN UPGRADES CAPITAL IMPROVEMENTS PROJECT TO BE ADDED TO FISCAL YEAR 2011 CAPITAL IMPROVEMENTS PROGRAM AND TO AUTHORIZE THE APPROPRIATION AND EXPENDITURE OF ADA IMPROVEMENTS ANNUAL ALLOCATION AND COMMUNITY DEVELOPMENT BLOCK GRANT FUNDS INVOLVING THE PROJECT

WHEREAS, the Housing and Community Development Act of 1974 established the Community Development Block Grant [CDBG] Program, which is administered by the U.S. Department of Housing and Urban Development [HUD]; and

WHEREAS, since the inception of the CDBG Program, the City of San Diego [City] has allocated CDBG funds to various organizations engaged in eligible activities that satisfy the national objectives of the CDBG Program; and

WHEREAS, in Fiscal Year [FY] 2007, pursuant to Resolution No. R-302033 on October 24, 2006, the Council of the City of San Diego [City Council] allocated forty-one thousand dollars (\$41,000) to the City of San Diego Park and Recreation Department to conduct ADA improvements to the kitchen of the South Clairemont Recreation Center; and

WHEREAS, in FY 2009, pursuant to Resolution No. R-303662 on May 6, 2008, the City Council allocated an additional thirteen thousand dollars (\$13,000) to the City of San Diego Park and Recreation Department to conduct ADA upgrades to the kitchen of the South Clairemont Recreation Center; and

WHEREAS, in FY 2010, pursuant to Resolution No. R-305403 on November 10, 2009, the City Council allocated an additional five thousand dollars (\$5,000) to the City of San Diego Park and Recreation Department to perform ADA upgrades to the kitchen of the South Clairemont Recreation Center; and

WHEREAS, pursuant to Annual Appropriations Ordinance No. O-19887 on July 27, 2009, the City Council allocated funds for the ADA Improvements Annual Allocation, CIP A-BE.00001;

WHEREAS, the City's Disabilities Services Program and the City's Park and Recreation Department desire to have forty thousand dollars (\$40,000) allocated from CIP A-BE.00001, the ADA Improvements Annual Allocation, to perform ADA upgrades to the kitchen of the South Clairemont Recreation Center;

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- That the South Clairemont Recreation Center ADA Kitchen Upgrades Project is
 established as CIP S-10134 and added to the Fiscal Year 2011 Capital Improvements
 Program;
- 2. That the Chief Financial Officer is authorized to transfer appropriations in the amount of forty thousand dollars (\$40,000) from CIP A-BE.000001, ADA Improvements Annual Allocation, to CIP S-10134, South Clairemont Recreation Center ADA Kitchen Upgrades, within Fund No. 400002, Capital Outlay, for the purpose of design and construction of the project contingent upon the Chief Financial Officer certifying that funds are available; and

- 3. That the Chief Financial Officer is authorized to expend forty thousand dollars (\$40,000) from CIP S-10134, South Clairemont Recreation Center ADA Kitchen Upgrades, Fund No. 400002, Capital Outlay, for the purpose of design and construction of the project contingent upon the Chief Financial Officer certifying that funds are available; and
- 4. That CDBG funds from the FY 2007, 2009, and 2010 allocations in the total amount of fifty-nine thousand dollars (\$59,000) shall be reallocated to CIP S-10134, South Clairemont Recreation Center ADA Kitchen Upgrades, in Fund No. 600000, Community Development Block Grants contingent upon the Chief Financial Officer certifying that funds are available; and
- 5. That the Chief Financial Officer is authorized to appropriate and expend fifty-nine thousand dollars (\$59,000) from CIP S-10134, South Clairemont Recreation Center ADA Kitchen Upgrades, Fund No. 600000, Community Development Block Grants, for the purpose of construction of the project contingent upon the Chief Financial Officer certifying that funds are available; and
- 6. That upon the completion and closure of the project, the Chief Financial Officer is authorized to transfer excess budgeted funds, if any, in South Clairemont Recreation Center ADA Kitchen Upgrades Fund No. 400002, Capital Outlay, to CIP A-BE.000001, ADA Improvements Annual Allocation; and

7. That upon project completion, any remaining available funds in South Clairemont Recreation Center ADA Kitchen Upgrades Fund No. 600000, Community Development Block Grants, shall be reported to City Council as available for reprogramming.
