A RESOLUTION DECLARING THE RESULTS OF THE MUNICIPAL PRIMARY ELECTION AND THE MUNICIPAL SPECIAL ELECTION HELD IN THE CITY OF SAN DIEGO ON JUNE 8, 2010.

WHEREAS, a municipal primary election was held in the City of San Diego on Tuesday, June 8, 2010, pursuant to the provisions of Ordinance No. O-19924 (New Series), adopted February 1, 2010, for the purpose of nominating candidates to the offices of Councilmember for Districts 2, 4, 6, and 8, and, if any candidate received a majority of all votes cast, for the purpose of electing that candidate; and

WHEREAS, a municipal special election was held in the City of San Diego on Tuesday, June 8, 2010, pursuant to the provisions of Ordinance No. O-19925 (New Series), adopted February 1, 2010, for the purpose of submitting to the qualified voters of the City of San Diego two propositions, described as follows:

- 1) One proposition regarding whether to amend the City Charter related to limitations and credits for veterans' preference points in Civil Service examinations (Proposition C); and
- 2) One proposition regarding whether to revise the City Charter related to the Strong Mayor form of governance (Proposition D); and

WHEREAS, both propositions required approval by a simple majority (over 50%) to be considered approved by the voters, and the propositions read as follows:

PROPOSITION C. AMENDS THE CITY CHARTER RELATING TO LIMITATIONS AND CREDITS FOR VETERANS' PREFERENCE POINTS. Shall the Charter be amended to extend eligibility for veterans' preference points in any original Civil Service examination to veterans who have served in the United States Armed Forces during any war, major military action or peacekeeping mission, and to provide an additional five percent credit for any veteran or the spouse of any veteran who has a qualifying service-related disability? PROPOSITION D. REVISES THE CITY CHARTER RELATING TO THE STRONG MAYOR FORM OF GOVERNANCE. Shall the Charter be revised to make permanent the Strong Mayor form of governance; add a ninth Council seat; and, when the ninth seat is filled, increase the number of Council votes required to override a mayoral veto to a two-thirds vote? WHEREAS, a copy of the certificate of the Registrar of Voters of San Diego County canvassing the returns of the municipal primary election and the municipal special election, as certified to the City Clerk, has been duly received; and

WHEREAS, a canvass of the municipal primary election and municipal special election has been completed and the City Clerk has certified the results to the City Council; and

WHEREAS, declaring the results of elections as certified by the Registrar of Voters and the City Clerk is a ministerial act required of the municipal governing body by California

Elections Code section 10263 and, therefore, is not subject to veto by the Mayor; NOW,
THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Section 27.0411 of the San Diego Municipal Code, as follows:

I

The whole number of votes cast in the City was 199,004.

II

The total vote received by each candidate at the municipal primary election is as follows:

A. FOR COUNCIL DISTRICT NO. 2 (four-year term)

JIM MORRISON	3,796 (13.67%)

KEVIN FAULCONER, having received a majority of all votes cast, is hereby declared elected to the office of Councilmember, District No. 2.

B. FOR COUNCIL DISTRICT NO. 4 (four-year term)

TONY YOUNG	9,628 (62.71%)
BRIAN POLLARD	5,683 (37.02%)

TONY YOUNG, having received a majority of all votes cast, is hereby declared elected to the office of Councilmember, District No. 4.

C. FOR COUNCIL DISTRICT NO. 6 (four-year term)

LORIE ZAPF	9,931 (36.18%)
HOWARD WAYNE	6,758 (24.62%)

STEVE HADLEY	4,846 (17.66%)
KIM TRAN	3,582 (13.05%)
RYAN HUCKABONE	2,275 (8.29%)

LORIE ZAPF and HOWARD WAYNE are hereby declared to be the candidates for the office of Councilmember, District No. 6, in the Municipal General Election.

D. FOR COUNCIL DISTRICT NO. 8 (four-year term)

FELIPE HUESO	2,581 (19.54%)
B.D. HOWARD	2,277 (17.24%)
NICK INZUNZA	2,234 (16.91%)

LINCOLN PICKARD	574 (4.34%)

DAVID ALVAREZ and FELIPE HUESO are hereby declared to be the candidates for the office of Councilmember, District No. 8, in the General Municipal Election.

III

The number of votes cast in the City for and against each of the two propositions which appeared on the ballot as Propositions C and D, and the total number of votes cast upon each proposition, are as follows:

PROPOSITION C

For	146,141 (75.17%)
Against	48,263 (24.83%)
TOTAL	194,404

Proposition C received the affirmative vote of a majority of the qualified voters voting on such proposition and is hereby declared to have been approved.

PROPOSITION D

For	120,107 (60.35%)
Against	78,897 (39.65%)
TOTAL	199,004

Proposition D received the affirmative vote of a majority of the qualified voters voting on such proposition and is hereby declared to have been approved.

IV

The number of votes cast in each precinct for each person, and for and against the propositions, is recorded in the Election Returns Book, which book is authorized and is considered to be a part of the record of this Council.

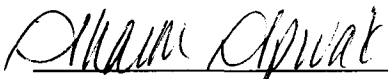
V
