BE IT RESOLVED, by the Council of the City of San Diego [Council] that the plans and specifications for the construction of the Sewer Pipeline Rehabilitation Phase J-1D Project, as advertised by the Purchasing and Contracting Department, and which are filed in the office of the City Clerk as Document No. RR- 306050, are approved.

BE IT FURTHER RESOLVED, that after advertising for bids in accordance with law, the Mayor, or his designee, is authorized to execute a construction contract with the lowest responsible and reliable bidder, in an amount not to exceed \$7,756,446 from CIP A-JA.00002, Annual Allocation - Pipeline Rehabilitation (B-00521), Fund 700000, Sewer, contingent upon approval of the Fiscal Year 2011 Appropriation Ordinance and provided that the City Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$7,756,446 from CIP A-JA.00002, Annual Allocation - Pipeline Rehabilitation (B-00521), Fund 700000, Sewer for the purpose of executing the aforementioned construction contract, contingent upon approval of the Fiscal Year 2011 Appropriation Ordinance and provided that the City Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
