DATE OF FINAL PASSAGE SEP 24 2010

A RESOLUTION APPROVING THE PLANS AND SPECIFICATIONS, AUTHORIZING THE EXPENDITURE OF FUNDS AND RELATED ACTIONS FOR CONSTRUCTION OF PACIFIC HIGHWAY TRUNK SEWER PROJECT.

WHEREAS, the City of San Diego has a Sewer Main Replacement Program as mandated by the Environmental Protection Agency; and

WHEREAS, the City intends to rehabilitate and replace sewer pipelines in the Centre City and Midway-Pacific Highway Community areas under the Pacific Highway Trunk Sewer Project [Project], which project is part of the aforementioned Program; NOW, THEREFORE,

BE IT RESOLVED, BY THE Council of the City of San Diego [Council] as follows:

1. That the plans and specifications for the construction of the Project, as advertised by the Purchasing and Contracting Department, filed in the office of the City Clerk as Document No. RR- 306125, are approved.


2. That after advertising for bids in accordance with law, the Mayor, or his designee, is authorized to award and execute a construction contract with the lowest responsible and reliable bidder, provided that the City Comptroller first furnishes one or more certificates certifying that funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the Chief Financial Officer is authorized to appropriate, and the City Comptroller is authorized to expend an amount not to exceed \$4,909,873.97 from CIP A-JB.00001 (Legacy CIP 40.933.0), Annual Allocation-MWWD Trunk Sewers, Fund 700000, Sewer, for the Project and related costs, contingent upon the approval of the Fiscal Year 2011 Appropriation Ordinance and the City Comptroller furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

4. That the Chief Financial Officer is authorized, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
