A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH AECOM, INC. FOR UPDATES TO THE MIDWAY-PACIFIC HIGHWAY CORRIDOR AND OLD SAN DIEGO (OLD TOWN) COMMUNITY PLANS.

WHEREAS, on July 22, 2008, the City Council initiated the update of the Midway-Pacific Highway Corridor and Old San Diego (Old Town) community plan; the Redevelopment Agency authorized the expenditure and transfer of up to \$1,600,000 of funds from the North Bay Redevelopment Project Area to fund the updates; and

WHEREAS, the City solicited a Request for Proposal (RFP No. 9468-09-W) for a multidisciplinary team to provide technical assistance and support to staff for the duration of the community plan update process; and

WHEREAS, a Technical Evaluation Community was formed to review and evaluate the technical proposals which team composed of City staff, two community representatives and advisors; and

WHEREAS, the Technical Evaluation Community recommended AECOM be awarded the contract; and

WHEREAS, AECOM will be assisted by several sub-consultants with extensive expertise in pertinent disciplines. Fehr and Peers will provide the transportation analysis and mobility expertise, MJE Marketing will conduct some of the public outreach and facilitation, True North Research will prepare a community survey, and Winter and Company, a firm with

national expertise in historic preservation and conservation districts, will assist with urban design; and

WHEREAS, the consultant team will work collaboratively with staff and provide a variety of professional services for the community plan updates. The staff will take the lead and the consultant team will have a role with project management and administration; meeting facilitation; conducting workshops and the charrette; preparing the urban design and mobility elements of the plan; providing technical expertise and review for the other elements; and preparing special studies; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee, is hereby authorized to expend \$947,940 from Fund No. 200359 NB RDA Planning Contribution, and to execute an Agreement with AECOM, Inc. to provide professional planning consultant services for the updates of the Midway-Pacific Highway Corridor and Old San Diego (Old Town) community plans.
