A RESOLUTION AUTHORIZING THE MAYOR OR HIS DESIGNEE TO ENTER INTO A CONTRACT BETWEEN THE FIRE-RESCUE DEPARTMENT AND SAN DIEGO SPORTS MEDICINE AND WELLNESS CENTER TO PROVIDE HEALTH SERVICES TO THE FIRE-RESCUE DEPARTMENT

WHEREAS, in December of 2004, the City Council approved resolution R-299936 authorizing the City Manager to execute an agreement with San Diego Sports Medicine and Family Health Center (SDSM) for the delivery of health services through the City of San Diego Fire-Rescue Wellness Program (Wellness Program);

WHEREAS, San Diego Fire-Rescue staff completed an RFP process (RFP 10007746-10-V) this year for a continuation of the Wellness Program, and SDSM has been selected to again provide this program; and

WHEREAS, firefighter wellness and medical fitness exams have proven to be a benefit to the citizens the firefighters serve. The SDSM Wellness Program meets the International Association of Fire Chiefs and International Association of Firefighters criteria for this type of program. The program is a benefit to the City through early identification and mitigation of risk factors that have potential for causing injuries, and illnesses in a hazardous and demanding work environment. WHEREAS, the Wellness Program has demonstrated itself to be a highly effective, lifesaving, and necessary component of the overall safety and health of our firefighters; and

WHEREAS, as the consultant and contract provider to the City, SDSM will provide regular and comprehensive reports to the Fire-Rescue Department executive staff. These reports will include the identification of new and/or existing firefighter health issues, trend analysis and suggested methods for improvement in firefighter fitness; and

WHEREAS, the total cost of the contract from FY2011 to FY2015 will be \$5,243,741 from the City's General Fund; and


WHEREAS, this cost requires an increase in the San Diego Fire-Rescue Department's original budget for the Wellness Program by a total of \$498,816; and

WHEREAS, the proposed agreement between the City and SDSM will not exceed five years in accordance with Charter Section 99; and

WHEREAS, this activity is not a project and is, therefore, not subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15060(c)(3); NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego hereby authorizes the Mayor or his designee to enter into an agreement between the City of San Diego and San Diego Sports Medicine Wellness Center; and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend up to \$5,243,741 from the General Fund to fulfill the contact obligation, of which \$948,985 is in FY2011 and all future amounts are contingent upon budget approval in the applicable Annual Appropriation Ordinance and upon certification of funding availability; and



BE IT FURTHER RESOLVED, that the Independent Budget Analyst or the City Auditor will conduct a cost savings analysis of the Wellness Program, and any proposed cost saving alternatives will be presented to the Public Safety and Neighborhood Services Committee within six months.
