A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO ACCEPTING AND APPROPRIATING FUNDS IN THE AMOUNT OF \$292,500 TO FUND THE TRANSITIONAL HOUSING PROGRAM FOR HOMELESS SENIORS.

WHEREAS, the Transitional Housing Program for Homeless Seniors (Program) is sponsored by the City of San Diego to provide homeless seniors with temporary housing and supportive services at housing facilities in downtown and surrounding neighborhoods; and

WHEREAS, the Redevelopment Agency has provided funding support to the Program since 2002 with expenditures from the Centre City or Horton Plaza Low and Moderate Income Housing Fund; and

WHEREAS, the Senior Community Centers of San Diego is expected to operate the Program on behalf of the City this year; and

WHEREAS, the City is requesting \$292,500 to fund leasing costs for 37 rooms and program administration for the 12-month period of July 2010 to June 2011; NOW,

THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the City 's Chief Financial Officer is authorized to accept and appropriate funds in the amount of \$292,500 from the Redevelopment Agency's FY 2011 Horton Plaza Low and Moderate Income Housing Fund No. 200540 to City Fund No. 200443- Transitional Housing Program for Homeless Seniors; and

2. That the City's Chief Financial Officer is authorized to expend funds in the amount of up to \$292,500 from City Fund No. 200443- Transitional Housing Program for Homeless Seniors, for the operation of the Program, contingent upon the Chief Financial Officer certifying availability of funds; and
3. That the City Council authorizes the Mayor or his designee to negotiate and execute an agreement with Senior Community Centers of San Diego to expend an amount not to exceed \$292,500 from City Fund No. 200443 – Transitional Housing Program for Homeless Seniors for the operation of the Program, contingent upon certification of availability of funds by the City's Chief Financial Officer.
