A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO APPROVING THE FY2011 HOMELESS EMERGENCY WINTER SHELTER PROGRAM FOR VETERANS; AUTHORIZING THE CHIEF FINANCIAL OFFICER TO EXPEND ANY FUNDS ASSOCIATED WITH THE PROGRAM: AND DESIGNATING A SHELTER SITE.

WHEREAS, a significant number of persons within the City of San Diego are without the ability to find shelter; and

WHEREAS, the City of San Diego has a significant shortage of shelter beds for those persons; and

WHEREAS, the weather conditions during the cold weather season result in a threat to the health and safety of those persons; and

WHEREAS, on April 6 and May 4, 2010, the City Council of the City of San Diego (Council) approved, by Resolution Nos. R-305741 and R-305864, acceptance and expenditure of \$660,147 in Emergency Shelter Grant (ESG) funds and \$856,809 in Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD), of which \$109,331 in ESG funds and \$111,069 in CDBG funds will be used for the Homeless Emergency Winter Shelter Program for Veterans; and

WHEREAS, on June 29, 2010, by Resolution No. R-305962, the City transferred oversight of the Emergency Winter Shelter Program to the San Diego Housing Commission (Commission), and authorized the Chief Financial Officer to transfer funds for the Homeless Emergency Winter Shelter Program; and

WHEREAS, the City has a contract with the Navy to site a sprung shelter that will house

up to 150 homeless male veterans at the SPAWAR location in the Midway area and Commission

staff is working to update this agreement so that the new responsibilities of the Commission can

be incorporated into that agreement; and

WHEREAS, the operator at this site will be Veteran's Village of San Diego (VVSD) and

VVSD will operate this program for 120 days (currently projected from December 8, 2010

through April 6, 2011) in substantial conformance with the FY2010 contract, which is attached

hereto; NOW, THEREFORE,

BE IT RESOLVED, that a homeless shelter crisis exists in the City of San Diego, in

accordance with California Government Code section 8698.2(a)(1); and

BE IT FURTHER RESOLVED, that the FY 2011 Homeless Emergency Winter Shelter

Program for Veterans (Program) is hereby approved upon certification of funds availability by

the City Auditor and Chief Financial Officer; and

BE IT FURTHER RESOLVED, that the Mayor or designee is hereby authorized to enter

into a contract that substantially conforms with the terms of the FY2010 contract with VVSD

and take any other necessary actions to implement the FY 2011 Homeless Emergency Winter

Shelter Program for Veterans.
