A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO DECLARING A HOMELESS SHELTER CRISIS IN THE CITY; AUTHORIZING THE SINGLE ADULT SHELTER PORTION OF THE FY2011 EMERGENCY SHELTER PROGRAM AS IS SET OUT IN HOUSING COMMISSION REPORT NO. CCR 10-008 UPON CERTIFICATION OF FUNDING BY CITY AUDITOR AND CHIEF FINANCIAL OFFICER; DESIGNATING A SITE FOR THE FY2011 WINTER SHELTER; AND AUTHORIZING THE MAYOR OR HIS DESIGNEE AND THE HOUSING COMMISSION TO PREPARE AND EXECUTE ANY DOCUMENTATION NECESSARY TO IMPLEMENT THE FY2011 EMERGENCY WINTER SHELTER PROGRAM.

WHEREAS, according to the Fiscal Year 2010 homeless profile compiled by the Regional Task force profile, there were an estimated 4,526 homeless persons living in the City of San Diego last winter; and

WHEREAS, of these persons, 2,049 were living on the streets as the City has insufficient beds to shelter these persons; and

WHEREAS, the weather conditions during the cold weather season result in a threat to the health and safety of those persons; and

WHEREAS, on April 6 and May 4, 2010, the City Council of the City of San Diego (Council) approved, by Resolution Nos. R-305741 and R-305864, acceptance and expenditure of \$660,147 in Emergency Shelter Grant (ESG) funds and \$856,809 in Community Development Block Grant (CDBG) funds from the U.S. Department of Housing and Urban Development (HUD), of which \$109,000 in ESG funds and \$100,000 in CDBG will be used for the Homeless Emergency Winter Shelter Program; and

WHEREAS, on June 29, 2010, by Resolution No. R-305962, the City transferred oversight of the Emergency Winter Shelter Program to the San Diego Housing Commission (Commission), and authorized the Chief Financial Officer to transfer funds for the Emergency Winter Shelter to the Housing Commission; and

WHEREAS, the Commission has developed a program for the FY2011 Emergency Winter Shelter Program, as discussed in Commission Report No. CCR 10-008; NOW THEREFORE,

BE IT RESOLVED, that a homeless shelter crisis exists in the City of San Diego, in accordance with California Government Code section 8698.2 (a)(1); and

BE IT FURTHER RESOLVED, that the Single Adult Shelter portion of the FY2011 Emergency Homeless Winter Shelter Program, as described in Housing Commission Report to City Council No. CCR 10-008 is approved upon certification of funds availability by the City Auditor and Chief Financial Officer; and

BE IT FURTHER RESOLVED, the property located at	Casiden	Hall	

is designated as the temporary site location of the Single Adult Shelter for the FY2011 Homeless Emergency Winter Shelter Program, and the Housing Commission shall carry out that program accordingly; and

BE IT FURTHER RESOLVED, that the Mayor or his designee and the Housing

Commission are hereby authorized to prepare and execute any documentation necessary to

proceed with implementation of the FY2011 Emergency Homeless Winter Shelter Program on the site designated by the City Council.
