BE IT FURTHER RESOLVED, that the expenditure of an additional amount not to exceed \$153,494 is hereby authorized, solely and exclusively to provide funds for the above amendment from the following sources: \$84,327 from Fund No. 400265, Contributions from General Fund, CIP A-CC.00001, Watershed CIP for Cabrillo Heights Park Watershed Protection Project (B-10025) and \$69,167 from Fund No. 400264, Private and Other Contributions, CIP S-00763, Cabrillo Heights Neighborhood Park Improvements.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to transfer excess budgeted funds, if any, to the appropriate reserves upon the advice of the administering department.

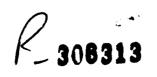
