BE IT FURTHER RESOLVED, that the use of City Force Work from Water Fund

700011, CIP No. A-KB.00003, Annual Allocation – Main Replacements (B-00092) in an amount

not to exceed \$180,000.00 is authorized for the construction and related costs of the Project.

from the administering department, to transfer excess budgeted funds, if any, to the appropriate

reserves.
