A RESOLUTION OF THE SAN DIEGO CITY COUNCIL
AUTHORIZING AN AGREEMENT TO SHARE COSTS OF
CHOLLAS CREEK CLEANUP WITH THE COUNTY OF
SAN DIEGO, CALTRANS, U.S. NAVY, PORT DISTRICT,
CITY OF LA MESA, AND CITY OF LEMON GROVE.

WHEREAS, the California Regional Water Quality Control Board has ordered a reduction in the total maximum daily load (TMDL) of dissolved metals in Chollas Creek by responsible parties discharging into the creek, which includes the City of San Diego; and

WHEREAS, the City and the other dischargers have implemented a plan for such TMDL reduction and have agreed to share costs of the water quality monitoring and reporting plan;

NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement to share costs of the Chollas Creek Dissolved Metals Total Maximum Daily Load Implementation Plan with the County of San Diego, the U.S. Navy, San Diego Unified Port District, the City of La Mesa, and the City of Lemon Grove, under the terms and conditions set forth in the Cost-Share Agreement, on file with the City Clerk as Document No. RR- 306369.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$196,690 from Fund No. 100000, solely and exclusively to provide funds under the Cost-Share Agreement, which includes the City's share of \$136,998, and provided the remaining \$59,692 shall be reimbursed to the City by the other parties according to the terms of the Cost and Share Agreement.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept total reimbursement of \$59,692 from the County of San Diego, the California Department of Transportation, the United States Navy, the San Diego Unified Port District, the City of La Mesa, and the City of Lemon Grove, to be deposited in the General Fund (Fund No. 100000) for the parties' allocated share costs as set forth in the Cost-Share Agreement.
