BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$2,000 from the Special Promotional Programs, Mayor and City Council Discretionary Funding, for the above described project, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
