- 2. If Real Party-in-Interest, Hillel of San Diego, elects to proceed with the processing of the Project, the City shall prepare an environmental impact report for the Project.

Make and file a return to this writ within 180 days from the date the writ is served.

The Court retains jurisdiction over Respondents pursuant to Public Resources Code section 21168.9(b). Upon determination by this Court that the actions taken by Respondents comply in all respects with the terms of this Peremptory Writ of Mandate and the California Environmental Quality Act, the Court shall discharge the Writ.
