A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
SAN DIEGO ACCEPTING THE 2010 GENERAL PLAN  
MONITORING REPORT AND ADOPTING MINOR GENERAL  
PLAN AMENDMENTS.

WHEREAS, on March 10, 2008, the City Council of the City of San Diego  
(City Council) adopted an update to the City's General Plan, which sets forth a long-range vision  
and comprehensive policy framework for how the City should plan for projected growth and  
development, provide public services, and maintain the qualities that define San Diego; and

WHEREAS, on July 7, 2009, the City Council adopted the General Plan Action Plan  
which provides a comprehensive implementation program for the General Plan and outlines the  
strategies and tools needed to bring together policy and action; and

WHEREAS, the 2010 General Plan Monitoring Report, on file in the Office of the City  
Clerk as Document No. RR-306419-1 (General Plan Monitoring Report), has been  
prepared and provides updates on the eight key implementation actions identified in the General  
Plan Action Plan as well as a status update of the Action Plan matrix; and

WHEREAS, the need for minor amendments to the General Plan, on file in the Office of  
the City Clerk as Document No. RR-306419-2 (Minor General Plan Amendments), have  
been identified to correct errors, ensure consistency with other adopted City documents and  
programs, and to refine trail policies; and

WHEREAS, an assessment of the General Plan implementation is needed to ensure that  
the vision of the General Plan continues to guide the City's actions and programs; and

WHEREAS, continued progress as documented in the General Plan Monitoring Report is being made to realize the goals of the General Plan through short-, mid- and long-term actions; and

WHEREAS, on June 24, 2010, the Planning Commission of the City of San Diego recommended acceptance of the General Plan Monitoring Report and approval of the Minor General Plan Amendments; and


WHEREAS, on October 6, 2010, the Land Use and Housing Committee of the City Council recommended that the City Council accept the General Plan Monitoring Report and approve the Minor General Plan Amendments; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the 2010 General Plan Monitoring Report is accepted.
2. That the Minor General Plan Amendments are adopted.
3. That the City Clerk is directed to file a Notice of Determination (NOD) with the

Clerk of the Board of Supervisors for the County of San Diego regarding the General Plan Monitoring Report and Minor General Plan Amendments.
