A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS REPRESENTATIVE TO APPROVE AND ACCEPT THE U.S. DEPARTMENT OF JUSTICE EVIDENCE-BASED LAW ENFORCEMENT INITIATIVE GRANT FOR THE PURPOSE OF DEVELOPING EFFECTIVE, ECONOMICAL, AND INNOVATIVE RESPONSES TO SPECIFIC CRIME PROBLEMS.

WHEREAS, the U.S. Department of Justice has implemented an evidence-based law enforcement initiative grant in the amount of \$485,000; and

WHEREAS, this grant will enable the San Diego Police Department to conduct an intensive, multi-faceted project, using Smart Policing Techniques that combines the power of intelligence led policing; predictive analysis and crime prevention with the oversight of community brokers and correctional monitors to sever the link between criminal organizations and their prospective talent pool - convicted offenders and desperately vulnerable adolescents; and

WHEREAS, all expenses resulting from this action are grant funded, there is no requirement for continued expenditures or services once grant funding is depleted or terminated; and

WHEREAS, approximately \$220,000 of Police Department funds is currently being expended in ongoing investigations associated with department work similar to the grant being awarded. Contract personnel will be hired via grant funds; and

WHEREAS, this program is subject to the City's Equal Opportunity Contracting (San Diego Ordinance No. 18173, Section 22.2701 through 22.2708) and Non-Discrimination in Contracting Ordinance (San Diego Municipal Code Sections 22.3501 through 22.3517); and

WHEREAS, the item has been presented to P&S on November 17, 2010; and

WHEREAS, there is no subcontractor activity associated with this action. This action does not authorize entering into any contract or agreement; however, future contacts or agreements associated with action may be subject to agency requirements; and

WHEREAS, this activity is not subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15060(c)(2); NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego hereby authorizes the Mayor or his designee to make application to US Department of Justice, and to take all necessary actions to secure funding for an amount of \$485,000 pertaining to the U.S. Department of Justice Smart Policing: Evidence-Based Law Enforcement Initiative.

BE IT FURTHER RESOLVED, that the Council authorizes the Chief Financial Officer to establish a special interest-bearing fund for the grants, if required.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept up to \$485,000 or the actual amount of funding authorized by the U.S. Department of Justice if the grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$485,000 or the actual amount of funding authorized by the U.S. Department of Justice, for the purpose of implementing the Smart Policing: Evidence-Based Law Enforcement Initiative.

BE IT FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate this program.
