RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEE TO APPLY FOR, AND ACCEPT UP TO \$5,452 IN GRANT FUNDS FROM FM GLOBAL INSURANCE COMPANY TOWARDS FIRE PREVENTION COMMUNITY EDUCATION MATERIALS; AUTHORIZING THE CHIEF FINANCIAL OFFICER TO APPROPRIATE AND EXPEND UP TO \$5,452 IF THE GRANT FUNDING IS SECURED, CONTINGENT UPON RECEIPT OF A FULLY EXECUTED GRANT AGREEMENT; AND, AUTHORIZING THE CITY COMPTROLLER TO ESTABLISH SEPARATE GRANT FUND FOR THIS GRANT AWARD.

WHEREAS, the FM Global Fire Prevention Grant funds projects across the country to support fire education and prevention; and

WHEREAS, the San Diego Fire-Rescue Department currently receives requests daily to make fire safety presentations to community groups, schools and senior centers; and

WHEREAS, additionally, the Department, when possible, participates in health and safety fairs around the City; and

WHEREAS, San Diego Fire-Rescue is requesting grant fimds to support the design and printing of community education materials to support these community presentations; and

WHEREAS, having brochures to take to these events will greatly enhance our presentation and provide the community with important information to take home and share with their families; and

WHEREAS, furthermore, electronic copies of these materials will be available for download by members of the community for times when SDFD is not able to provide presentations in person; and

WHEREAS, the FM Global grant opportunity does not require a local match; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized, on behalf of the City, to apply for, and accept up to, \$5,452 in grant fimds from FM Global Insurance Company towards fire prevention community education materials.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$5,452 if the grant funding is secured, contingent upon receipt of a fully executed grant agreement.

BE IT FURTHER RESOLVED, that the City Comptroller is authorized to establish separate grant fund for this grant award.
