A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO RATIFYING THE ELECTION RESULTS OF THE OCTOBER 25, 2010 AND OCTOBER 26, 2010 ELECTION FOR THE CENTRE CITY REDEVELOPMENT PROJECT AREA COMMITTEE AND THE CENTRE CITY ADVISORY COMMITTEE.

WHEREAS, on September 11, 1990, the City Council of the City of San Diego, by Resolution No. R-276511, adopted the "Procedures for the Formation of a Project Area Committee for the Centre City Redevelopment Project" (Formation Procedures), and has subsequently adopted certain amendments to those Formation Procedures; and

WHEREAS, on November 6, 2001, the Council, by Resolution No. R-295698, established the Centre City Advisory Committee (CCAC) and approved the CCAC Bylaws, which Bylaws have been subsequently amended by the CCAC and the Center City Redevelopment Project Area Committee (PAC); and

WHEREAS, California Community Redevelopment Law (Law) requires that PACs remain in existence for three years from the date of adoption of the redevelopment plan and are thereafter subject to one-year extensions by the legislative body; and

WHEREAS, on November 2, 2010, the Council, by Resolution No. R- 300473, approved a one-year extension of the PAC; and

WHEREAS, the annual PAC and CCAC election was conducted on October 25, 2010 and October 26, 2010, after notice and in accordance with the Formation Procedures of the PAC, the Bylaws of the CCAC and PAC, and applicable law; and


WHEREAS, a representative from the City Clerk's Office attended the counting of ballots for the annual PAC and CCAC election on October 27, 2010, to ensure its validity and provide official verification of the tallying of ballots; NOW, THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego, as follows:

1. That the Project Area Committee for the Centre City Redevelopment Project and the Centre City Advisory Committee, including those persons who received the highest number of votes in their respective categories and listed on Attachment A, attached hereto and incorporated by this reference, are approved as constituting a representative Project Area Committee and Centre City Advisory Committee.

2. That the Council finds that the election results of October 25, 2010 and October 26, 2010 are valid and binding in accordance with the Formation Procedures of the Project Area Committee and the Bylaws of the Centre City Advisory Committee and Project Area Committee.
