WHEREAS, Rule 6.11.1 states that the Council President shall serve as the Chair of the Rules Committee and that the Council President Pro Tem shall serve as the Vice-Chair; and

WHEREAS, the City Council has selected Councilmember Anthony Young to serve as Council President for a second term, which commenced on December 6, 2010; and

WHEREAS, the Council President has submitted nominations for each committee Chair, vice-chair, and committee members for calendar year 2011; and

WHEREAS, under Charter section 280(a)(1), this resolution is not subject to veto by the Mayor because this matter is exclusively within the purview of the City Council and not affecting the administrative service of the City under the control of the Mayor; NOW, THEREFORE,
