

ORDINANCE NUMBER O- 20016 (NEW SERIES)

DATE OF FINAL PASSAGE JAN 18 2011

AN ORDINANCE AMENDING CHAPTER 5, ARTICLE 6, DIVISION 0 OF THE SAN DIEGO MUNICIPAL CODE BY AMENDING SECTION 56.54, RELATING TO THE PROHIBITION OF ALCOHOL CONSUMPTION AT KATE O. SESSIONS MEMORIAL PARK.

WHEREAS, San Diego Municipal Code section 56.54(c) currently prohibits the consumption of alcohol at Kate O. Sessions Memorial Park (Park) during a twelve-hour period each day from 8:00 p.m. to 8:00 a.m.; and

WHEREAS, the citizens of the City of San Diego voted to completely ban the consumption of alcohol on its beaches, a measure known as Proposition D, in the November 4, 2008 election;

WHEREAS, since that time, there has been a substantial increase in use of the Park by individuals who engage in excessive alcoholic binge drinking behavior to the detriment of the Park and the surrounding community; and

WHEREAS, despite the daily twelve-hour alcohol ban, there are numerous incidents of public intoxication in and around the Park, including: loud noise disturbances, public drunkenness, public urination, driving under the influence of alcohol, and indecent exposure resulting in increased calls for service to the San Diego Police Department; vast amounts of litter and debris at the Park which reduces the enjoyment of residents and visitors and requires the additional expenditure of City funds for Park maintenance; and

WHEREAS, such events have been growing in frequency and duration in recent months, straining City resources and interfering with the peace of the neighboring residential community, as well as heightening the risk to public safety; and

WHEREAS, the City Council desires to alleviate the negative impacts described above by making it unlawful to consume alcohol within the Park; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That Chapter 5, Article 6, Division 0 of the San Diego Municipal Code is amended by amending Section 56.54, to read as follows:

§56.54 Alcoholic Beverage Consumption Prohibited in Certain Areas

Section 3. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.


