AN ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO APPROVING THE TRANSFER OF A NON-  
EXCLUSIVE SOLID WASTE COLLECTION FRANCHISE  
FROM EMERALD WASTE TO WASTE MANAGEMENT  
AND AUTHORIZING A CONSENT TO ASSIGNMENT OF  
THE EMERALD WASTE FRANCHISE AGREEMENT.

WHEREAS, Emerald Waste & Recovery, Inc. (Emerald) has a Class I non-exclusive franchise and franchise agreement with the City for the collection and management of solid waste; and

WHEREAS, Emerald wishes to transfer its franchise to Waste Management of California, Inc., a current City solid waste collection and management franchisee;

WHEREAS, the transfer of the franchise requires City Council approval under San Diego Charter section 103; and

WHEREAS, the Natural Resources & Culture Committee considered and recommended approval of this transfer on December 1, 2010; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the transfer of the Class 1 Non-Exclusive Franchise for Solid Waste Management Services from Emerald Waste & Recovery, Inc. to Waste Management of California, Inc. is approved.

Section 2. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a consent to the assignment of the franchise and the franchise agreement, as set forth in

the Consent to Assignment of Class 1 Non-Exclusive Franchise Agreement for Solid Waste Management Services, on file with the City Clerk as Document No. OO- 20029.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
