ORDINANCE OF THE COUNCIL OF THE CITY OF  
SAN DIEGO AUTHORIZING THE MAYOR TO EXECUTE A  
SOLE SOURCE BRIDGE CONTRACT FOR CONSULTANT  
SERVICES WITH THE SAN DIEGO STATE UNIVERSITY  
RESEARCH FOUNDATION TO PROVIDE REGIONAL  
PROJECT MANAGEMENT AND CLEARINGHOUSE  
SUPPORT FOR ONGOING GRANT PROGRAMS UNTIL A  
COMPETITIVELY BID CONTRACT IS IN PLACE

WHEREAS, on behalf of the San Diego Urban Area [SDUA], the City entered into a five-year contract with San Diego State University Research Foundation [SDSURF], a non-profit corporation, in 2006 to provide support for our regional homeland security grant program; and

WHEREAS, under the contract currently funded by the Urban Area Security Initiative [UASI] grants, SDSURF provides project management, regional collaboration, a technology clearinghouse, and regional technology strategic planning support services across the SDUA as an independent judge of technology, a neutral interface between regional jurisdictions and vendors offering competing technology solutions, and best practices in applying available technology to leverage scarce first response resources within the SDUA; and

WHEREAS, this contract has been funded on an annual basis with a five-year limit expiring on April 6, 2011; and

WHEREAS, a request for proposal has been developed and is being finalized for release for open competition; and

WHEREAS, the delay in federal release of the FY11 Homeland Security Grant Program guidance and application process has impacted our ability to identify the complete scope of work needed to support the projects that will be covered under the grant program; and

WHEREAS, with ongoing regional grant projects requiring full-time project managers to ensure completion of the projects within the grant performance period, it is critical that we retain the current contracted management structure until the competitive process is completed and a new contract is in place; and

WHEREAS, this request for a sole source bridge contract will allow for continued management of the grant funded projects and provisions of technology subject matter expertise to support the development of the pending grant project proposals beyond the current April 6, 2011 contract deadline; and

WHEREAS, it is expected that the request for proposal for the new contract will be released in March, with a new contract projected to be in place no later than June of 2011; and

WHEREAS, this bridge contract will be issued at a cost not to exceed \$500,000 to allow for unexpected delays in the issuance of a new contract; and

WHEREAS, there is no non-federal match or cost share required under the grant program that will support this contract; and

WHEREAS, this bridge contract will be funded under the FY09 UASI grant program; and

WHEREAS, the grant is reimbursable in nature requiring the City of San Diego to expend funds prior to requesting reimbursement; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego as follows:

Section 1. The Mayor or his designee is authorized, on behalf of the City, to execute an extension to the contract with SDSURF, under the terms and conditions set forth in the extension agreement on file in the Office of the City Clerk as document number OO- 20041 for the

Regional Homeland Security Grant Program Support Services contract in grant 1000019-2009, UASI, in an amount not to exceed \$500,000.


Section 2. The Mayor or his designee is authorized, on behalf of the City, to expend up to \$500,000 from grant 1000019-2009, UASI, for the purpose of executing this contract.

Section 3. The full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the Public prior to the day of its passage.

Section 4. This ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
