AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN EXTENSION TO THE AGREEMENT WITH VERIZON WIRELESS (VAW), LLC, TO PROVIDE WIRELESS GOODS AND SERVICES AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE SERVICES.

WHEREAS, the City and Verizon entered into an agreement to provide wireless telephone and equipment services for up to five years, effective as of December 1, 2005 (Agreement), as approved by Council Resolution No. R-302259; and

WHEREAS, the City and Verizon desire to extend the Agreement, to continue the services through September 8, 2011; and

WHEREAS, in order to expedite approval of this action, the matter has been directly docketed for City Council consideration; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an amendment to the Agreement with Verizon Wireless (VAW), LLC, to extend the Agreement to provide wireless telephone service and equipment through September 8, 2011, under the terms and conditions set forth in Amendment No. 1, on file with City Clerk as Document No. OO- 20045.

Section 2. That the expenditure of an amount not to exceed \$1,700,000 is authorized for the above Amendment No. 1, to be expended as follows:

(a) \$991,453 in Fiscal Year 2011, consisting of \$677,279 from the General Fund and \$314,174 from various Non-General Funds, as detailed in the Comptroller's Certificate Number 3000003897; and

(b) \$708,547 in Fiscal Year 2012, contingent on such funding being included in the Fiscal Year 2012 Appropriation Ordinance and provided that the City Comptroller furnishes one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.

Section 3. That City staff is requested to perform an analysis of options regarding City use of cellular services and to bring the analysis to Committee, and to provide the Council with a list of contracts and related expiration dates for contracts scheduled to expire during the 2011 calendar year.

Section 4. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 5. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
