

ORDINANCE NUMBER O- 20050 (NEW SERIES)

DATE OF FINAL PASSAGE MAY 09 2011

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AMENDING ORDINANCE NO. O-19976 (NEW SERIES) ENTITLED "AN ORDINANCE ADOPTING THE ANNUAL BUDGET FOR THE FISCAL YEAR 2011 AND APPROPRIATING THE NECESSARY MONEY TO OPERATE THE CITY OF SAN DIEGO FOR SAID FISCAL YEAR," BY AUTHORIZING THE CHIEF FINANCIAL OFFICER TO APPROPRIATE AND EXPEND AIRPORT ENTERPRISE FUNDS IN ACCORDANCE WITH THE REVISION TO THE FISCAL YEAR 2011 BUDGET.

WHEREAS, on July 26, 2010, the City Council adopted San Diego Ordinance No. O-19976, entitled "An Ordinance Adopting The Annual Budget For The Fiscal Year 2011 And Appropriating The Necessary Money To Operate The City Of San Diego For Said Fiscal Year" (Fiscal Year 2011 Appropriation Ordinance); and

WHEREAS, the Mayor has proposed revisions to the Fiscal Year 2011 budget; and

WHEREAS, on MAY 09 2011, the City Council caused a hearing to be held before the City Council's Budget and Finance Committee to consider the proposed revisions to the Fiscal Year 2011 budget; and

WHEREAS, on MAY 09 2011, 2011, the City Council held a second public hearing to consider the proposed revisions to the Fiscal Year 2011 budget, in accordance with sections 71 and 290 of the Charter of the City of San Diego; and

WHEREAS, the City Council has adopted Resolution R- 306791, approving the revisions to the Fiscal Year 2011 budget as proposed by the Mayor; and

WHEREAS, an amendment to the Fiscal Year 2011 Appropriation Ordinance is necessary to authorize the Chief Financial Officer to increase the Airports Enterprise Fund, Fund No. 700033, budget by \$254,600 from available fund balance to support continuing ongoing operations and maintenance that assist safe aircraft operations through the maintenance of safe runways, taxiways, lighting, infields and general infrastructure at Montgomery Field; and

WHEREAS, pursuant to sections 280 (a) (4) and 290 (d) of the Charter of the City of San Diego, the Mayor has no veto power over this ordinance; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Fiscal Year 2011 Appropriation Ordinance is hereby amended consistent with Resolution R- 306791 to authorize the Chief Financial Officer to increase the Airports Enterprise Fund, Fund No. 700033, budget by \$254,600, and to appropriate and expend those funds to support continuing ongoing operations and maintenance that assist safe aircraft operations through the maintenance of safe runways, taxiways, lighting, infields and general infrastructure at Montgomery Field.

Section 2. That this ordinance is declared to take effect and be in force immediately upon passage after two public hearings pursuant to the authority contained in sections 71, 275 and 295 of the Charter of the City of San Diego.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been available to the City Council and the public prior to the day of its passage.
