AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A SECOND AMENDMENT EXTENDING THE AGREEMENT WITH VERIZON WIRELESS (VAW), LLC, TO PROVIDE WIRELESS GOODS AND SERVICES AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR THE SERVICES.

WHEREAS, the City and Verizon entered into an agreement to provide wireless telephone and equipment services for up to five years, effective as of December 1, 2005 (Agreement), as approved by Council Resolution No. R-302259; and

WHEREAS, by Ordinance No. O-20045 passed on April 26, 2011, the Council authorized an extension to the agreement through September 8, 2011; and

WHEREAS, the City and Verizon desire to again extend the Agreement, to continue the services through the earlier of the date the City terminates for convenience as provided for in Section 27.4 of the Agreement, as amended, or March 8, 2012; and

WHEREAS, in order to expedite approval of this action, the matter has been directly docketed for City Council consideration; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a second amendment to the Agreement with Verizon Wireless (VAW), LLC, to extend the Agreement to provide wireless telephone service and equipment through the earlier of the date the City terminates for convenience as provided for in Section 27.4 of the Agreement, as amended, or March 8, 2012, under the terms and conditions set forth in Amendment No. 2 to the Agreement, on file with City Clerk as Document No. OO-\_\_\_\_\_\_\_.

Section 2. That the expenditure of an amount not to exceed \$750,000 for Fiscal Year 2012 is authorized for the above referenced Amendment No. 2, consisting of \$461,451 from the General Fund and \$288,549 from various Non-General Funds, as detailed in Comptroller's Certificate Number 3000004344, with expenditures not to exceed \$125,000 per month.

Section 3. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 4. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
