

ORDINANCE NUMBER O- **20102** (NEW SERIES)

DATE OF FINAL PASSAGE **OCT 18 2011**

AN ORDINANCE OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A SIXTH AMENDMENT TO AN AGREEMENT WITH AECOM TECHNICAL SERVICES, INC. FOR THE LA JOLLA VILLAGE DRIVE/INTERSTATE 805 AND MIRAMAR ROAD WIDENING PROJECTS IN THE UNIVERSITY CITY COMMUNITY PLAN AREA AND RELATED ACTIONS.

WHEREAS, on March 29, 2002 the City and AECOM Technical Services [AECOM] executed a consultant agreement to provide professional services related to the improvement of the La Jolla Village Drive and Interstate 805 Interchange and related improvements to Miramar Road; and

WHEREAS, this consultant agreement has subsequently been amended on January 28, 2003 (1<sup>st</sup> Amendment), May 10, 2004 (2<sup>nd</sup> Amendment), October 24, 2006 (3<sup>rd</sup> Amendment), December 4, 2007 (4<sup>th</sup> Amendment), and September 16, 2008 (5<sup>th</sup> Amendment); and

WHEREAS, the City and AECOM now desire to execute a 6<sup>th</sup> Amendment to provide additional services to accommodate adjacent land developments and changes to Caltrans requirements; and

WHEREAS, a developer contribution in the amount of \$135,914 will be used to provide for the construction of an additional travel lane on eastbound La Jolla Village Drive as necessitated by developer impacts; NOW, THEREFORE,

BE IT ORDAINED, by the Council of the City of San Diego, as follows:

Section 1. That the Mayor be and he is hereby authorized and empowered to execute, for and on behalf of said City, the sixth amendment to an agreement with AECOM for professional services under the terms and conditions set forth in the Agreement on file in the Office of the

City Clerk as Document No. OO- 20102 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

Section 2. That the Chief Financial Officer is authorized to increase the Fiscal Year 2012 Capital Improvement Program Budget, CIP S-00857, La Jolla Village Drive/Interstate 805, by an amount not to exceed \$135,914.00.

Section 3. That the expenditure of an amount not to exceed \$135,914.00 from CIP S-00857, La Jolla Village Drive/Interstate 805, Fund 400264, Private & Others Contrib-CIP, is authorized, solely and exclusively for the purpose of providing funds for Project, provided that the Chief Financial Officer first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.


Section 4. That the expenditure of an amount not to exceed \$484,492.00 from CIP S-00857, La Jolla Village Drive/Interstate 805, Fund 400080, North University City, and \$116,110.00 from CIP S-00880, Miramar Road Widening, Fund 400080, North University City, is authorized for the purpose of executing the sixth amendment for the above-referenced Project.

Section 5. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.

Section 6. That a full reading of this ordinance is dispensed with prior to its passage, a written or printed copy having been made available to the City Council and the public prior to the day of its passage.

Section 7. That this ordinance shall take effect and be in force on the thirtieth day from and after its final passage.
