A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A ONE-YEAR EXTENSION OF THE NORTH BAY REDEVELOPMENT PROJECT AREA COMMITTEE AND AUTHORIZING STAFF OF THE REDEVELOPMENT AGENCY OF THE CITY OF SAN DIEGO TO NOTICE AND CONDUCT THE ANNUAL NORTH BAY REDEVELOPMENT PROJECT AREA COMMITTEE ELECTION IN 2011.

WHEREAS, California Community Redevelopment Law, Section 33385 of the California Health and Safety Code, provides that a legislative body of the city shall call upon the residents and existing community organizations in a redevelopment project area to form a project area committee; and

WHEREAS, California Community Redevelopment Law, Section 33386 of the California Health and Safety Code, provides that the redevelopment agency shall consult with the project area committee on policy matters which affect the residents of the project area throughout the period of preparation of the redevelopment plan and for a three year period after the adoption of the redevelopment plan, subject to one-year extensions by the legislative body; and

WHEREAS, on September 30, 1997, by Resolution No. R-289249, the City Council of the City of San Diego (Council) adopted the Procedure for Formation of a Project Area Committee for the North Bay Redevelopment Project San Diego, California (Procedures) for the North Bay Redevelopment Project Area Committee (PAC); and

WHEREAS, on July 15, 2003, by Resolution No. R-298201 the Council approved an amendment to the Procedures for the PAC; and

WHEREAS, the Procedures, as amended, provide that the Council may authorize the Redevelopment Agency of the City of San Diego (Agency) staff to notice and conduct the annual PAC election; and

WHEREAS, in accordance with California Health and Safety Code Section 33386, Agency staff is requesting that the Council extend the PAC for one additional year; and

WHEREAS, the Council believes that the input from the PAC and the relationship between the Agency and the PAC is important to the successful implementation of the North Bay Redevelopment Plan and the North Bay Redevelopment Project Area; NOW THEREFORE,

BE IT RESOLVED, by the City Council of the City of San Diego as follows:

- 1. That the Council hereby authorizes the PAC be extended for one additional year.
- 2. That the Council hereby directs the Agency staff to notice and conduct the annual PAC election in 2011.
