DATE OF FINAL PASSAGE JAN 28 2011

A RESOLUTION AUTHORIZING THE COUNCIL OF THE CITY OF SAN DIEGO TO ALLOCATE AN ADDITIONAL \$300,000 TO SUPPORT THE LITIGATION COSTS RELATED TO THE CITY OF SAN DIEGO'S DAMAGES SUSTAINED IN THE WILDFIRES OF 2007.

WHEREAS, the City of San Diego [City] filed a Complaint on June 19, 2008, and a subsequent First Amended Complaint on November 5, 2008; and

WHEREAS, after filing of the above complaints, numerous other cases were filed alleging that San Diego Gas & Electric [SDG&E] was responsible for damages resulting from the Wildfires of 2007. The court ordered the cases be organized under four Master Complaints; included were those for Individual Claimants, Class Claimants, Government Claimants, and Insurance Claimants. The City is joined by the County of San Diego, and the State of California (i.e., Cal Fire) in the Governmental Entities Group; and

WHEREAS, damages (i.e. FEMA) for fire suppression are approximately \$22 million dollars. In addition, the City has expended approximately \$5 million dollars of its own money. Environmental damages are estimated at approximately \$30 million dollars. Total damages approximate \$55 million dollars; and

WHEREAS, the City has expended approximately \$250,000 on litigation support. This request will add \$300,000 to pay for the services necessary to further litigate this case through mediation and prior to date of trial; NOW, THEREFORE,

BE IT FURTHER RESOLVED, authorize an additional \$300,000 to support the costs of litigation in the City's lawsuit related to the City's damages sustained in the Wildfires of 2007.

These costs include, litigation experts, mediation expenses, joint experts, deposition costs, repository costs, and trial preparation costs; and

BE IT FURTHER RESOLVED, authorize the Chief Financial Officer to appropriate and expend the amount of \$174,284 from the Public Liability Fund 720045 for the litigation costs mentioned above, contingent upon the Chief Financial Officer first furnishing one or more certificates that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, authorize the Chief Financial Officer to expend the amount of \$7,858 from the Metropolitan Sewer Fund 700000 for the litigation costs mentioned above, contingent upon the Chief Financial Officer first furnishing one or more certificates that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer; and

BE IT FURTHER RESOLVED, authorize the Chief Financial Officer to expend the amount of \$117,858 from the Water Fund 700011 for the litigation costs mentioned above, contingent upon the Chief Financial Officer first furnishing one or more certificates that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
