A RESOLUTION OF THE SAN DIEGO CITY COUNCIL AUTHORIZING A MEMORANDUM OF UNDERSTANDING WITH STORM WATER CO-PERMITTEES FOR SHARED COSTS TO PURSUE AN UNFUNDED MANDATE CLAIM WITH THE CALIFORNIA COMMISSION ON STATE MANDATES.

WHEREAS, by Order R 9-2007-0001 of the San Diego Regional Water Quality Control Board, the City of San Diego was issued a permit for its storm water conveyance system, Permit No. CAS0108758, which is shared by the following eighteen co-permittees: County of San Diego and the cities of Carlsbad, Chula Vista, Coronado, Del Mar, El Cajon, Encinitas, Escondido, Imperial Beach, La Mesa, Lemon Grove, National City, Oceanside, Poway, San Marcos, Santee, Solana Beach, and Vista (co-permittees); and

WHEREAS, the City and the co-permittees have pursued a test claim with the California Commission on State Mandates (Commission) that certain requirements in the permit constitute unfunded state mandates; and

WHEREAS, the County and a majority of the co-permittees have entered a cost sharing Memorandum of Understanding to pursue the test claim; and

WHEREAS, as the co-permittees have requested the City of San Diego's participation in the sharing of costs; and

WHEREAS, the City may substantially benefit from supporting this effort; and

WHEREAS, in conjunction with this action, a cross-petition was filed in Sacramento County Superior Court in July 2010 on behalf of the co-permittees, *County of San Diego, et al,* v. Commission on State Mandates, Case No. 34-2010-80000604; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with the storm water co-permittees for the sharing of costs associated with the prosecution of an unfunded state mandates claim to the State Water Resources Control Board, under the terms and conditions set forth in the Memorandum of Understanding, on file with the City Clerk as Document No.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend an amount not to exceed \$195,841 from Fiscal Year 2011 General Fund No. 10000, Storm Water Department Pollution Prevention Division Operating Fund No. 211400, solely and exclusively to provide funds for the City's allocated portion of the shared costs pursuant to the above Memorandum of Understanding.
