A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING APPLICATION TO SANDAG FOR THE ACTIVE COMMUNITY TRANSPORTATION GRANT PROJECT.

WHEREAS, SANDAG is administering grant funding from the County of San Diego Health and Human Services Agency, which is implementing the Communities Putting Prevention to Work (CPPW) program created by the Centers for Disease Control and Prevention with American Recovery and Reinvestment Act Funds; and

WHEREAS, the funding from the grants is to be used in combating rising obesity rates in the San Diego region by planning communities in ways that support increased physical activity and access to healthy foods; and

WHEREAS, SANDAG will issue the funds through four pass-through grant programs to local government agencies, tribal governments, community programs, and school districts; and

WHEREAS, the grants are intended to promote public health through innovative community planning, the creation of safe routes to school, and the development of active transportation programs to support biking and walking; and

WHEREAS, grant applications are due on February 15, 2011 and will be awarded in March 2011; and

WHEREAS, SANDAG's Active Community Transportation Grant Program is to promote pedestrian and bicycle-friendly neighborhoods; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego as follows:


1. The Mayor or his designee is authorized to make an application to SANDAG, execute the grant agreement, and to take all necessary actions to secure finding for an amount of \$50,000 in Active Community Transportation grant funds for the San Ysidro Pedestrian Bridges Enhancement project, and \$50,000 in Healthy Community Planning grant funds for the Community Gardens and Urban Agriculture Land Development Code Amendments project and ensure the completion of the scope of work by February 1, 2012.

2. The Chief Financial Officer is authorized to accept up to \$50,000 in Active Community Transportation funds for the San Ysidro Pedestrian Bridges Enhancement project, and \$50,000 in Healthy Community Planning grant funds for the Community Gardens and Urban Agriculture Land Development Code Amendments project if the grant funding is secured.

3. The Chief Financial Officer is authorized to establish a special interest-bearing account if required for each project.

4. The Chief Financial Officer is authorized to appropriate and expend up to \$50,000 for the purpose of San Ysidro Pedestrian Bridges Enhancement project and \$50,000 for the purpose of the Community Gardens and Urban Agriculture Land Development Code Amendments project, contingent upon receipt of a fully executed grant agreement.
