A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING A TRANSFER OF FUNDS AND THE EXPENDITURE OF THESE FUNDS FOR THE OCEAN BEACH/HOTEL CIRCLE BIKE PATH PROJECT.

WHEREAS, the Ocean Beach / Hotel Circle North Bikeway project extends the existing

Ocean Beach bike path along the north side of Interstate 8 between Ocean Beach and the Pacific

Highway to the western terminus of Hotel Circle Place; and

WHEREAS, the bike path alignment passed through both Caltrans and Metropolitan

Transit System (MTS) right-of-way; and

WHEREAS, construction of the project was recently completed and the bike path is open for public use; and

WHEREAS, the coordination necessary to obtain the required permits from both Caltrans and MTS resulted in additions to the project scope of work and cost; and

WHEREAS, the additional project scope and cost necessitate additional funds to pay final project costs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Chief Financial Officer is authorized to transfer an amount not to exceed \$100,000 from CIP S-00660, Public Roads Supporting Park Access, to S-00949, Ocean Beach/Hotel Circle Bike Path, within Fund 400156 Transnet Prop A ½ cent Sales Tax.
- 2. That the expenditure of an amount not to exceed \$100,000 from CIP S-00660, Public Roads Supporting Park Access, to S-00949, Ocean Beach/Hotel Circle Bike Path, is authorized,

solely and exclusively for the purpose of providing funds for the Ocean Beach/Hotel Circle Bike Path, provided that the City Comptroller first furnishes one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.

3. That the City Comptroller, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
