A RESOLUTION OF THE CITY COUNCIL AUTHORIZING A SECOND AMENDMENT TO THE LEASE AGREEMENT WITH HAWTHORNE MACHINERY COMPANY FOR HEAVY DUTY TRACTOR BULLDOZERS; AND AUTHORIZING THE EXPENDITURE OF FUNDS FOR SUCH AMENDMENT.

WHEREAS, on May 25, 2010, by Resolution No. R-305868, the City Council approved an Agreement with Hawthorne Machinery Company for the lease of heavy duty tractor bulldozers for daily operations at the Miramar Landfill [Agreement], retroactive to March 15, 2009 through July 14, 2010; and

WHEREAS, on July 13, 2010, by Resolution No. R-305979, the City Council approved the First Amendment to the Agreement, authorizing an extension of the term of the Agreement beginning July 15, 2010 through March 14, 2011, with options to renew for three additional one-year periods, with options subject to City Council approval; and

WHEREAS, the City wishes to exercise the first option to renew the Agreement for an additional one-year period; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, a second amendment to the Agreement with Hawthorne Machinery Company, for the lease of heavy duty tractor bulldozers with full maintenance, extending the term of the Agreement for one additional year, beginning March 15, 2011 through March 14, 2012, with options to renew for up to two additional one-year periods subject to City Council approval, all in accordance with

the terms and conditions set forth in the Second Amendment to the Agreement, on file with the City Clerk as Document No. RR- 306659.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$1,625,000 from Refuse Disposal Fund No. 700039, solely and exclusively to provide funds for the Second Amendment to the Agreement, contingent on passage of the Annual Appropriations Ordinance for the applicable fiscal year and provided that the City Comptroller first furnishes one or more certificates demonstrating that the funds are, or will be, on deposit in the City Treasury.
