A RESOLUTION OF THE COUNCIL OF THE CITYOF SAN DIEGO AUTHORIZING THE EXTENSION OF THE AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND VOLUNTEERS OF AMERICA FOR THE TWO-YEAR PERIOD OF JULY 1, 2010 THROUGH JUNE 30, 2012 FOR THE SERVICES OF A DROP-OFF CENTER FOR THOSE CHRONICALLY INEBRIATED AND UNDER THE INFLUENCE.

WHEREAS, the City is aware of the on-going public presence of public inebriation and its negative impact upon City communities, in particular the downtown tourist areas. The City views this as a behavioral and/or mental issue, not a public safety program requiring incarceration; and

WHEREAS, in FY2009 the City executed an agreement with Volunteers of America (VOA) to provide the services of a drop-of Center as needed and as determined by the Police Department. Services consist of providing resources to allow the inebriated a treatment bed for a minimum of four hours. Upon the client's return to sobriety, the VOA Center provides counseling via printed materials regarding alcoholism and to allow the inebriated a treatment bed for a minimum of four hours. The printed materials are produced by the Center or may be obtained from an organization such as Alcoholics Anonymous. The Center operates on a 24-hour/7 day-a-week basis to allow Police drop-off. It is estimated that the VOA Center services approximately 8,000 inebriated clients annually; and

WHEREAS, under the terms and conditions of the FY2009 agreement there were four one-year options to renew. The FY2010 contract extension was approved by Mayoral Action (C-15348). The Purchasing and Contracting Department has ratified the contract for FY2011.

FY2011 Purchase Agreement 4500017687 for \$130,000 has been established. Volunteers of America has continued to provide services to the City for FY2011 and the cost will not exceed \$130,000. Appropriations of \$130,000 are included in the FY2011 Budget for Fund 200113 Police Decentralization; and

WHEREAS, this program is subject to the City's Equal Opportunity Contracting (San Diego Ordinance No. 18173, Section 22.2701 through 22.2708) and Non-Discrimination in Contracting Ordinance (San Diego Municipal Code Section Sections 22.3501 through 22.3517); and

WHEREAS, the item has been presented to P&S on November 17, 2010; and

WHEREAS, there is no subcontractor activity associated with this action. This action does not authorize entering into any contract or agreement; however, future contacts or agreements associated with action may be subject to agency requirements; and

WHEREAS, this activity is not subject to the California Environmental Quality Act (CEQA) pursuant to State CEQA Guidelines section 15301; NOW THEREFORE,

BE IT RESOLVED, that the Council of the City of San Diego hereby authorizes the Mayor or his designee to exercise the third and fourth-year options of a five-year agreement, for FY2011 and FY2012, with Volunteers of American for drop-off Center services.

BE IT FURTHER RESOLVED, that the Council of the City of San Diego hereby authorizes the Chief Financial Officer to expend up to \$130,000 in FY2011 and up to \$60,000 in FY2012 for those services, contingent upon the FY2012 Appropriations Ordinance and the Comptroller certifying that funds are available.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$130,000 for the FY2011 and as authorized up to \$60,000 for FY2012.

BE IT FURTHER RESOLVED, that the Chief of Police is authorized to administer and operate this program.
