SUMMARY VACATION OF AN IRREVOCABLE OFFER OF DEDICATION FOR A PORTION OF DEL MAR MESA ROAD AS SHOWN ON DOCUMENT NO. 2000-0538110 AND A PORTION OF SHAW RIDGE ROAD.

WHEREAS, California Streets and Highways Code section 8330 *et seq.* and San Diego Municipal Code section 125.0901 *et seq.* provide a procedure for the summary vacation of public rights of way by City Council resolution; and

WHEREAS, it is proposed that a portion of Del Mar Mesa Road, known as a portion of Shaw Ridge Road, Public Right-of-Way Vacation No. 781640, Project No. 219543, as more particularly described in the legal description marked as Exhibit "A," and as shown on Drawing Nos. 36294-1-B and 36294-2-B, marked as Exhibit "B," be vacated; and

WHEREAS, the public right-of-way has been superseded by relocation, and the vacation will not cut off all access to an individual property that, before the relocation, adjoined the public right-of-way; and

WHEREAS, the public right of way to be vacated does not contain public utility facilities; and

WHEREAS, under Charter Section 280(a)(2), this resolution is not subject to veto by the Mayor because this matter requires the City Council to act as a quasi-judicial body, a public hearing was required by law implicating due process rights of individuals affected by the decision, and the Council was required by law to consider evidence at the hearing and to make legal findings based on the evidence presented; and

BE IT RESOLVED, by the Council of the City of San Diego, that with respect to a portion of Del Mar Mesa Road, known as a portion of Shaw Ridge Road, Public Right-of-Way Vacation No. 781640, Project No. 219543, as more particularly described in the legal description marked as Exhibit "A," and as shown on Drawing Nos. 36294-1-B and 36294-2-B, marked as Exhibit "B," the Council finds that:

(a) There is no present or prospective use for the public right-of-way, either for the purpose for which originally acquired, or for any other public use of a like nature that can be anticipated.

In 2000, an Irrevocable Offer of Dedication (IOD) was accepted by the City that provided right of way (ROW) for the proposed public street, Del Mar Mesa Road, that was to replace the non-public, prescriptive easement known as Shaw Ridge Road that the existing residents on the Mesa used for access at that time. Due to a dispute with a property owner regarding the dedication of right of way for Del Mar Mesa Road, a condemnation proceeding was started by the City which eventually was resolved in a Settlement Agreement that dedicated a slightly different ROW for the same section of the road. This accepted alignment was constructed and the City has accepted Del Mar Mesa Road for service as a public road. Therefore, there is no present or prospective use for this portion of the public right-of-way.

(b) The public will benefit from the vacation through improved use of the land made available by the vacation.

The public will benefit from the vacation through improved use of the land made available by the vacation, as the land is already being developed upon and across these unused easements

(c) The vacation does not adversely affect any applicable land use plan.

The Del Mar Mesa Community Plan designates the site and area for low-density residential development. Improving the right-of-way alignment by adherence to the settlement agreement will reduce the liability of the City of San Diego at this location.

(d) The public facility for which the right-of-way was originally acquired will not be detrimentally affected by this vacation.

The dedicated and accepted Del Mar Mesa Road, Document No. 2002-0127121, adequately accesses the residential development planned for this area. Therefore, the public facility for which the right-of-way was originally acquired will not be detrimentally affected by this vacation.

BE IT FURTHER RESOLVED, that portion of Del Mar Mesa Road, known as a portion of Shaw Ridge Road, Public Right-of-Way Vacation No. 781640, Project No. 219543, as more particularly described in the legal description marked as Exhibit "A," and as shown on Drawing Nos. 36294-1-B and 36294-2-B, marked as Exhibit "B," which said drawing are attached hereto and made a part hereof, is ordered vacated.

BE IT FURTHER RESOLVED, that the Development Services Department shall record a certified copy of this resolution with attached exhibits, attested by the City Clerk under seal, in the office of the County Recorder.
