DATE OF FINAL PASSAGE MAR 16 2011

A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING AN AGREEMENT WITH UCSD
TO PROVIDE LIFEGUARD SERVICES AT BLACK'S BEACH.

WHEREAS, the coastal area known as Black's Beach is adjacent to property owned by the Regents of University of California (UC Regents); and

WHEREAS, lifeguard service at Black's Beach was decreased due to budget reductions that took place during Fiscal Year 2010; and

WHEREAS, the City of San Diego and the UC Regents have proposed an agreement that would fully restore lifeguard service at Black's Beach year round; and

WHEREAS, if implemented, this agreement will allow the City to obtain reimbursement from the UC Regents for the lifeguard services provided; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


Section 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with the UC Regents, under the terms and conditions set forth in the agreement on file as Document No. RR-306687.

Section 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$502,873 for the purpose of providing funds for the first term of the agreement (\$152,520 in FY 2011 and \$350,353 in FY 2012) provided that the Comptroller first issues one or more certificates demonstrating that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.

Section 3. That the Mayor or his designee is authorized to execute the two one-year options to extend the agreement, not to exceed \$524,661 per year, contingent on approval of such funding for each one-year option in the respective FY 2012 and FY 2013 Appropriations Ordinances, and provided that the Comptroller first issues one or more certificates demonstrating that the funds necessary for the expenditure are, or will be, on deposit with the City Treasurer.
