DATE OF FINAL PASSAGE MAR 2 5 2011

A RESOLUTION AUTHORIZING APPROVAL OF PLANS AND SPECIFICATIONS; AUTHORIZING AWARD OF PUBLIC WORKS CONTRACTS; AND TAKING RELATED ACTIONS REGARDING THE SLURRY SEAL OF STREETS PROJECTS FOR FISCAL YEAR 2010, GROUPS III AND IV.

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the plans and specifications, as advertised by the Contract Administrator, Purchasing and Contracting Department for bids, are approved for the following projects:
- (a) Slurry Seal Fiscal Year 2010, Group III, under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR- 336692-1; and
- (b) Slurry Seal Fiscal Year 2010, Group IV, under the terms and conditions set forth in the Agreement on file with the City Clerk as Document No. RR- 306692-.
- 2. That after advertising for bids in accordance with law, the Mayor or his designee is authorized to award and execute construction contracts for the above projects, provided that the Chief Financial Officer certifies that the funds are, or will be, on deposit with the City Treasurer, to be awarded as follows:
- (a) to the Lowest Responsible and Reliable Bidder in an amount not to exceed \$2,934,150 for Slurry Seal, Fiscal Year 2010, Group III; and
- (b) To the lowest responsible and reliable Small Local Business Enterprise (SLBE) or Emerging Local Business Enterprise (ELBE) pursuant to San Diego Municipal Code section 22.3316 for Slurry Seal, Fiscal Year 2010, Group IV.
- 3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$4,040,000, solely and exclusively to provide funds for the above projects and related costs.

contingent on the Chief Financial Officer certifying that the funds are available, to be expended as follows:

- (a) an amount not to exceed \$3,340,000 for Fiscal Year 2010 Slurry Seal Group III, consisting of \$3,150,000 from Fund No. 200306, Assembly Bill 2928; \$100,000 from Fund No. 200038, Rancho Bernardo Maintenance Assessment District; \$70,000 from Fund No. 200037, Mira Mesa Maintenance Assessment District; and \$20,000 from Fund No. 200081, Camino Santa Fe Maintenance Assessment District; and
- (b) an amount not to exceed \$700,000 for Slurry Seal, Fiscal Year 2010, Group IV, from Fund No. 200306, Assembly Bill 2928.
