A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE CITY OF SAN DIEGO AND SANDAG FOR THE I-15 INTEGRATED CORRIDOR MANAGEMENT PROJECT.

WHEREAS, the U.S. Department of Transportation has instituted the Integrated Corridor Management Initiative (ICM) to improve safety and mobility within transportation corridors; and

WHEREAS, the goal of the initiative is to develop and provide organizational guidance. operational capabilities, and intelligent transportation system technical methods to local/regional agencies for effective integrated corridor management; and

WHEREAS, the Interstate 15 corridor in the San Diego region was selected by the U.S. Federal Highway Administration as one of eight sites in the nation to participate in the development of an ICM in partnership with Caltrans, the San Diego Association of Governments (SANDAG), the Metropolitan Transit System (MTS), the North County Transit District (NCTD), and the cities of San Diego, Poway, and Escondido; and

WHEREAS, the City and SANDAG desire to enter into an agreement whereby SANDAG will reimburse the City for an amount not to exceed \$225,809 for City staff participation in the ICM Initiative; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is hereby authorized and empowered to execute, for and on behalf of said City, an Agreement for Project Support and Contribution with SANDAG, for the City support services related to the I-15 Integrated Corridor Management

[Project] for an amount not to exceed \$225,809.00 under the terms and conditions set forth in the Agreement on file in the Office of the City Clerk as Document No. RR-396693 together with any reasonably necessary modifications or amendments thereto which do not increase project scope or cost and which the Mayor shall deem necessary from time to time in order to carry out the purposes and intent of this project and agreement.

2. That the Chief Financial Officer, upon advice from the administering department, is authorized to transfer excess budgeted funds, if any, to the appropriate reserves.
