A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING AN AGREEMENT WITH ROTORCRAFT SUPPORT, INC. FOR HELICOPTER MAINTENANCE FOR THE SAN DIEGO POLICE DEPARTMENT'S FOUR HELICOPTERS; AND AUTHORIZING EXPENDITURES FOR THE MAINTENANCE OF THOSE HELICOPTERS.

WHEREAS, the San Diego Police Department [Police Department] has four helicopters for which it requires maintenance and overhaul in accordance with Federal Aviation Administration [FAA] regulations; and

WHEREAS, the four helicopters fly a total of 3,500 hours per year and respond to over 8,200 radio calls; and

WHEREAS, the manufacturer and the FAA require the helicopters to be inspected and maintained every one hundred, five hundred, one thousand, fifteen hundred, and two thousand hours of operation; and

WHEREAS, on September 28, 2006, the City of San Diego initiated a competitive process and advertised a Request for Bids (Bid No. 8431-07-P) to furnish the City with helicopter maintenance for its police and fire helicopters; and

WHEREAS, the City received two bids in response to the advertisement; and

WHEREAS, by letter dated January 8, 2007, Rotorcraft Support, Inc. was selected as the successful bidder and was awarded a contract; and

WHEREAS, the contract was for a period of one year beginning January 19, 2007, with options to renew for four additional one-year periods; and

WHEREAS, by letter dated November 2, 2007, the City exercised the first option to renew the contract for one year, from January 18, 2008, through January 17, 2009; and

WHEREAS, by letter dated December 1, 2008, the City exercised the second option to renew the contract for an additional year, from January 18, 2009, through January 17, 2010; and

WHEREAS, by letter dated January 27, 2010, the City exercised the third option to renew the contract for an additional year, from January 19, 2010, through January 18, 2011; and

WHEREAS, by letter dated January 19, 2011, the City exercised the fourth and final option to renew the contract for an additional year, from January 19, 2011, through January 18, 2012; and

WHEREAS, the Parties wish to amend the contract to add provisions required by the Equal Benefits Ordinance, enacted by Ordinance No. O-2011-17 Rev. (codified at San Diego Municipal Code sections 22.4301 et seq.), which became effective on January 1, 2011; and

WHEREAS, the contract is for five calendar years, but spans six fiscal years; and

WHEREAS, the contract provides for two full-time certified aircraft mechanics, and a third mechanic as needed, and Original Equipment Manufacturer parts, as needed; and

WHEREAS, most of the repair expenses during the first two years of operation were covered under pre-negotiated warranties; and

WHEREAS, without Council approval to ratify this contract and for expenditure of funds for helicopter maintenance, the Police Department will be unable to maintain the helicopters according to FAA regulations; and

WHEREAS, without compliance with FAA regulations, the Police Department will be forced to immediately ground all four helicopters; NOW, THEREFORE,


BE IT RESOLVED, by the Council of the City of San Diego, as follows:

1. That the Mayor or his designee is authorized, for and on behalf of the City, to ratify the five-year contract together with any amendments, with Rotorcraft Support, Inc., for helicopter maintenance, repair parts, and ongoing mechanic services for four Police Department helicopters.

2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,100,000 in Fiscal Year 2011 from the Seized and Forfeited Assets Funds (200220, \$900,000; 200221, \$940,000; 200222, \$40,000; and 200223, \$220,000) for the fourth year of the Rotorcraft Support, Inc. contract.

3. That the Chief Financial Officer is authorized to expend an amount not to exceed \$2,100,000 in Fiscal Year 2012 from the Seized and Forfeited Assets Funds (200220, 200221, 200222, and 200223) for the fifth year of the Rotorcraft Support, Inc. contract, contingent upon adoption of the Fiscal Year 2012 Annual Budget Appropriation Ordinance, and upon the Chief Financial Officer certifying that the funds necessary for expenditure are or will be available.
