A RESOLUTION OF THE CITY COUNCIL AUTHORIZING AN AGREEMENT WITH AECOM TECHNICAL SERVICES AND AUTHORIZING THE EXPENDITURE OF FUNDS IN CONNECTION WITH THE CITY'S CLIMATE MITIGATION AND ADAPTATION PLAN.

WHEREAS, the Council by Resolution No. R-306353 in November 2010 established the City's climate mitigation and adaptation plan (Climate MAP) to implement energy efficiency and conservation; and

WHEREAS, in furtherance of Climate MAP, the firm of AECOM was selected to provide technical support to the City, funded from grant allocations; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

- 1. That the Mayor or his designee is authorized to execute, for and on behalf of the City, an agreement with AECOM Technical Services for technical support in connection with the City's climate mitigation and adaptation plan, under the terms and conditions set forth in the Agreement, on file with the City Clerk as Document No. RR-____306701.
- 2. That the Chief Financial Officer is authorized to expend an amount not to exceed \$85,000 from Grant # 1000251-2009 (Energy Efficiency and Conservation Block Grant), Fund No. 600000 (Federal Grant), solely and exclusively to provide funds for the above agreement.
