A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO AUTHORIZING THE ACCEPTANCE AND
ASSIGNMENT OF A TRANSNET SMART GROWTH
INCENTIVE GRANT TO THE CITY
REDEVELOPMENT AGENCY AND OTHER ACTIONS
RELATED TO THE PARK BOULEVARD / CITY
COLLEGE / SAN DIEGO HIGH SCHOOL
PEDESTRIAN IMPROVEMENTS & TRANSIT ACCESS
PROJECT.

WHEREAS, in May of 2009 the Engineering & Capital Projects ["E&CP"] Department received a \$300,000 TransNet Smart Growth Incentive Program grant from San Diego Association of Governments ["SANDAG"] for the Park Boulevard / City College / San Diego High School Pedestrian Improvements & Transit Access Improvements Project ["Project"]; and

WHEREAS, the improvements will increase pedestrian safety by providing "pop-outs" on both sides of Park Boulevard in front of San Diego High School / City College and provide for the installation of a lighted crosswalk; and

WHEREAS, this is a joint project of the City of San Diego and the San Diego Redevelopment Agency ["RDA"], with the Centre City Development Corporation ["CCDC"] as the lead agency for the design and construction of the improvements;

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor, or designee, is authorized to accept a Smart Growth Incentive Program Grant from SANDAG, in the amount of \$300,000 for the Project.

2. That the Mayor, or designee, is authorized and empowered for and on behalf of the City to assign the grant application to the RDA for the Project.

3. That the Mayor, or his designee, is authorized to enter into a Cooperative Agreement with the RDA, and SANDAG, which will transfer all funds and responsibilities to CCDC, to implement the Project.

4. That the City Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.
