RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE MAYOR OR HIS DESIGNEES TO ACCEPT, APPROPRIATE, AND EXPEND ADDITIONAL FUNDING NOT TO EXCEED \$400,000 UNDER THE FY2008 STATE HOMELAND SECURITY GRANT PROGRAM

WHEREAS, the State Homeland Security Grant Program [SHSP] is a component of the Department of Homeland Security's 2008 Homeland Security Grant Program; and

WHEREAS, activities implemented under the SHSP must support terrorism preparedness by building or enhancing capabilities that relate to the prevention of, protection from, response to, and recovery from terrorism in order to be considered eligible; and

WHEREAS, many capabilities which support terrorism preparedness simultaneously support preparedness for other hazards and catastrophic incidents; and

WHEREAS, the activities must align with the national, state, and urban area strategic objectives; and

WHEREAS, strengthening preparedness planning, expanding capabilities in improvised explosive attack deterrence, prevention and protection, and maximizing information sharing are high priorities across all level of strategic objectives; and

WHEREAS, the City of San Diego [City] received an initial grant funding amount totaling \$843,214, authorized by Resolution 304213; and

WHEREAS, this authorization request will provide for an additional amount of grant funding not to exceed \$400,000 awarded through the County of San Diego [County] as the core county for the San Diego region under the FY2008 SHSP; and

WHEREAS, the additional funding will allow the San Diego Police Department and the Fire-Rescue Department to continue with the means to enhance their preparedness, prevention, and response capabilities; and

WHEREAS, these additional funds must be expended by April 30, 2011; and

WHEREAS, the San Diego Police Department will fund additional equipment and training to strengthen its communication capabilities, enhance information sharing, collaboration and law enforcement investigations, and improve protection of critical infrastructure and response capabilities; and

WHEREAS, the Fire-Rescue Department's specialized technical rescue team will use the funds for participation in regional exercises to enhance their response to all hazards, including those requiring the capability to coordinate and conduct search and rescue efforts; and

WHEREAS, there is no non-federal match or cost share required for grants under the SHSP covered by this resolution; and

WHEREAS, this grant is reimbursable in nature, requiring the City to expend an amount not to exceed \$400,000 prior to requesting reimbursement from the county; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Mayor, Chief Operating Officer, Chief Financial Officer, Fire Chief, or the Office of Homeland Security Program Manager is authorized, on behalf of the City, to take all necessary actions to secure

funding from the California Emergency Management Agency via the County of San Diego
Office of Emergency Services for an amount up to \$400,000 in grant funds for the City of San
Diego in order to support the implementation of the State Homeland Security Strategy to address
identified equipment, training, and exercise needs to prevent, protect against, respond to, and

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to accept up to \$400,000 if the grant funding is secured.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to expend up to \$400,000 from Fund #600000, Grant Fund-Federal, 1000031-2008, FY2008 State Homeland Security Grant Program for the purpose of supporting the implementation of the State Homeland Security Strategy to address identified equipment, training, and exercise needs to prevent, protect against, respond to, and recover from acts of terrorism and other catastrophic events, if the grant funding is secured.
