A RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING THE EXECUTION OF A FIRST AMENDMENT TO AN AGREEMENT WITH RRM DESIGN GROUP FOR THE 25TH STREET RENAISSANCE PROJECT.

WHEREAS, the 25th Street Renaissance Project will provide traffic calming improvements to improve pedestrian safety, provide additional street parking, as well as streetscape improvements to enhance the aesthetics of the 25th Street corridor; and

WHEREAS, the City and RRM Design Group entered into an agreement, that is on file in the Office of the City Clerk as Document No. C-15299 dated July 16, 2010, to provide professional engineering services for the 25th Street Renaissance Phase 1 Project [Project] and

WHEREAS, the City and RRM Design Group now desire to execute a First Amendment to the Agreement to complete Phase II of the Project; and NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:


1. That the Mayor, or his designee, is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to an Agreement with RRM Design Group, for additional professional services, under the terms and conditions set forth in the Agreement on file in the office of the City Clerk as Document No. RR 306727.

2. That the expenditure of an amount not to exceed \$313,561.00 from S-00985, the funding of which is from Fund 600001, Grant 1000302-2010 (Federal Grant), Fund 600001, Grant 1000303-2010 (State Grant), and from Fund 400169, TransNet, for the 25th Street Renaissance [Project] is authorized for the purpose of executing the First Amendment to the

Agreement with RRM Design Group, contingent upon the City Comptroller first certifying that funds are available for the above referenced Project.

3. That the City Comptroller, upon advice from the administering department, is authorized to transfer excess funds, if any, to the appropriate reserves.


