A RESOLUTION OF THE COUNCIL OF THE CITY OF
SAN DIEGO WAIVING PORTIONS OF COUNCIL
POLICY 100-03, AND ALLOCATING DISCRETIONARY
TOT FUNDING TO SPRINGFEST, INC.

WHEREAS, funds were allocated in the Fiscal Year 2011 Annual Budget for Special Promotional Programs intended to advance the City's economy by promoting the City of San Diego as a visitor destination in the national and international marketplace; and

WHEREAS, the mission of Springfest, Inc., is to bring together the residents to enhance the quality of life, create better relationships among the residents and businesses, and establish a safer, cohesive environment for all; and

WHEREAS, Springfest, Inc., is a non-profit community-based organization located in the Navajo community area of Allied Gardens, Del Cerro, Grantville, and San Carlos; and

WHEREAS, the Springfest, Inc., has requested funding to allow them to enhance current planning, coordinating, and production of the Springfest Festival, Movie in the Park, and Concert in the Park; and

WHEREAS, it is the determination of the Council that the Springfest, Inc., program fits within the parameters of the Special Promotional Programs set forth in the Fiscal Year 2011 Annual Budget; and

WHEREAS, the City desires to enter into an agreement with Springfest, Inc., to promote and Springfest, Inc., has agreed to promote the Arts and Cultural elements of our community; and


WHEREAS, Springfest, Inc., has proposed to expend \$113,300 for these projects and has requested the City of San Diego provide \$12,000 in funding for the projects from the Special Promotional Programs, Mayor and City Council Discretionary Funding line item set forth in the Special Promotional Programs portion of the Annual Budget; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that all general requirements of Council Policy 100-03 regarding application and funding recommendations are hereby waived.

BE IT FURTHER RESOLVED, that the Mayor, or his designee, is authorized to negotiate and execute for and on behalf of the City, an Agreement in an amount not to exceed \$12,000 for the Springfest, Inc., programs.

BE IT FURTHER RESOLVED, that the Chief Financial Officer is authorized to appropriate and expend up to \$12,000 from the Special Promotional Programs, Mayor and City Council Discretionary Funding, for the above described project, contingent upon the Chief Financial Officer first furnishing one or more certificates certifying that the funds necessary for expenditure are, or will be, on deposit with the City Treasurer.
