RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO AUTHORIZING REVISIONS TO THE ADOPTED FISCAL YEAR 2011 BUDGET OF THE CITY OF SAN DIEGO TO PROVIDE ADDITIONAL FUNDS FOR MAINTENANCE AND INFRASTRUCTURE PROJECTS AT MONTGOMERY FIELD AIRPORT.

WHEREAS, on June 14, 2010, the Council of the City of San Diego adopted Resolution No. R-305886 (Budget Resolution) approving the budget for conducting the affairs of the City of San Diego for the Fiscal Year commencing July 2, 2010, and ending June 30, 2011 (Fiscal Year 2011); and

WHEREAS, the Mayor vetoed the Budget Resolution and the Council overrode such veto on June 29, 2010; and

WHEREAS, on July 26, 2010, the City Council adopted San Diego Ordinance No.

O-19976, entitled "An Ordinance Adopting the Annual Budget for the Fiscal Year 2011 and

Appropriating the Necessary Money to Operate the City of San Diego for Said Fiscal Year"; and

WHEREAS, the Mayor has now proposed to revise the Fiscal Year 2011 Budget
Resolution for the purpose of continuing ongoing operations and maintenance that assist safe
aircraft operations through the maintenance of safe runways, taxiways, lighting, infields and
general infrastructure at Montgomery Field; and

WHEREAS, a minimum of two public hearings to consider the proposed budget revisions have been held in accordance with sections 71 and 290 of the Charter of the City of San Diego; and

WHEREAS, the City Council desires to approve the budget revisions as proposed by the

Mayor; NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego:

1. That the Fiscal Year 2011 Budget Resolution is hereby revised to increase the

Airports Enterprise Fund, Fund No. 700033, budget by \$254,600 from available fund balance to

support continuing ongoing operations and maintenance that assist safe aircraft operations,

through the maintenance of safe runways, taxiways, lighting, infields and general infrastructure

at Montgomery Field.

2. That the Chief Financial Officer is authorized to appropriate and expend \$254,600

in the Airports Enterprise Fund, Fund No. 700033, to support continuing ongoing operations and

maintenance that assist safe aircraft operations through the maintenance of safe runways,

taxiways, lighting, infields and general infrastructure at Montgomery Field.
